A. Scope of work:

The contractor is required to complete the Dismantling of the shed including old DG-Set and shifting and commissioning it at the new 33KV Substation including installation of Proper Silencer pipes as per requirement through technically trained and experienced manpower as per approved rates and guidelines of Jr. Electrical Engineer without any fault as per **Annexure-I**.

B. PRE QULIFICATION CRITERA:

Technical Eligibility: The bidder shall have satisfactorily completed similar works-

Experience of having successfully completed works during the last 7 years ending previous day of last date of submission of tender:

Three similar completed works, each costing not less than the amount equal of 40.0% of estimated cost put to tender i.e Rs. 1.11 lakh.

Or

Two similar completed works, each costing not less than the amount equal to 60% of estimated cost put to tender i.e.Rs.1.67 lakh.

Or

One similar completed works of aggregate cost not less than the amount equal to 80% of estimated cost put to tender i.e Rs. 2.23 lakh.

“Similar works” shall mean work of Dismantling, Shifting and Silencer pipe extension of DG-Set.
